


# **Bonnerworth Park Redevelopment**



In October 2023 a staff report was approved by Council that recommended the Bonnerworth Park Redevelopment Strategy. As stated in the report, the project aligns perfectly with the Community & Wellbeing Strategic Priority Pillar.

Also, the addition of 16 outdoor lit pickleball courts is not only required to meet the current need, but also offers up a tremendous tourism opportunity to attract larger scale tournaments.

## Opposition to the Plan

There has been growing opposition to the plan by the neighbors and concerned community members. Other than the debate of whether there was sufficient consultation, the two major reasons for the opposition are:

## Taking Away Green Space

The growing consensus from those that oppose the plan is the fact that such a large green area (2 ball diamond fields plus) will be paved over for courts and parking. And the current three tennis courts that are already used for pickleball be will be turned into a parking lot.

## Negatively affects to the Neighborhood

Neighbors are very concerned about the noise, traffic, and stormwater and they believe when these studies are completed it will show that this is project should not go forward.

The current green space is also currently being used by the neighbors doing a wide variety of activities (walking dogs, kite flying, baseball, soccer, playing with children, etc).



## The Location is the Issue

It has been reported that the city staff conducted a comprehensive investigation of all possible park locations for this development, but does it need to be in a park?

Could potentially we look to a different location, where the concrete courts & parking would improve the property, and the neighbors would welcome the investment?
